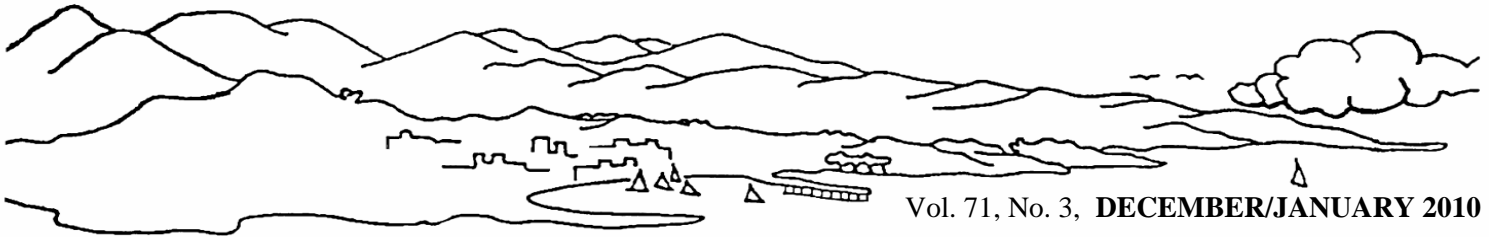

The START treaty is the first arms control agreement between the U. S. and Russia in nearly a decade. It calls for regular inspections and timely exchanges of information regarding nuclear arsenals.

LEAGUE OF WOMEN VOTERS OF CALIFORNIA HAILS VOTERS' CONFIRMATION OF REDISTRICTING REFORM

PROPOSITION 27 IS DEFEATED

On November 2, California voters decisively rejected Proposition 27 and the attempt to destroy the far-reaching redistricting reform passed by the voters in 2008. The League of Women Voters hails the election result. Californians understood that Proposition 27 was a politicians' scheme to seize power from the voters and avoid accountability. They saw it for what it was, and stopped it dead in its tracks. Proposition 20, which adds congressional redistricting to the work of the independent Citizens Redistricting Commission, also passed on November 2. The voters have spoken, and while the League opposed Proposition 20 as premature, it is committed to doing the utmost to make the redistricting process—now including congressional districts—to work well for the people of California.

The League remains committed to working with partners in the government reform and voting rights communities to achieve the best possible implementation of the Citizens Redistricting Commission that Californians have so clearly stated they want. League members will continue to monitor the process, educate the public, and engage in grass roots efforts to empower communities and neighborhoods across the state to fully participate in all phases of the mapping process.

With this election behind us, it's time for the Commission and all Californians to get to work and make redistricting reform a reality for California.

REDISTRICTING OBSERVER CORPS AND MEDIA WATCH TRAINING

Wednesday, January 12 from 7 to 7:45pm

Here's your chance to join a great new League project! A key element of the new redistricting process is its transparency; the public will be able to watch and to give input to the Citizens Redistricting Commission at its meetings all across the state.

You can help keep the public informed about how redistricting is being implemented, by joining the new **LWV Observer Corps and Media Watch** group. The goals are to give League members and the public a running account of how the process is working; and at the end, to issue a 'Report Card' about how well it actually worked. Similarly, the Media Watch observers will look at whether, and how, the Commission activities are being reported by the press and other media.

If you can't attend a meeting in person, you can watch meetings streamed live on the Internet, or videos posted of the proceedings at [the State Auditor's redistricting Web site](http://theStateAuditor'sredistrictingWeb.site): www.wedrawthelines.ca.gov.

The first 8 members of the Redistricting Commission have just been chosen. The new Commission meetings start November 30, with selection of the remaining 6 members by December 31. Then the Commission will start its work in earnest, drawing the lines.

Learn more about the Redistricting Observer Corps and how to report your observations by participating in an online training session, or "webinar", on **Wednesday, January 12 from 7 to 7:45pm**. Observers will be filing reports online, so this session will explain how to do it.

PLAN SANTA BARBARA DISAGREEMENT STILL UNRESOLVED

On November 23, the Santa Barbara City Council failed to adopt the City's long-debated General Plan Update (Plan Santa Barbara) and said that it would next be considered in February. At that time new Council Member and former Planning Commissioner Bandy White volunteered to work on the Ad Hoc Committee that has been trying to negotiate a compromise between the opposing views on increasing housing density downtown.

When the Council's Ad Hoc Committee broke up after an acrimonious meeting on November 19th, no new progress had been made. League hoped that the agreements worked out in two prior sessions would remain in place, because we had supported them actively. Those changes had removed High Density designations from the historic area downtown and along State Street. They had also added some high density along the Haley-Cota corridor, where land is cheaper and there are some possible sites for building the affordable housing the city wants.

The League had worked with the Citizens Planning Association (CPA), Coastal Housing Coalition and John Campanella to write a letter to the Council supporting the early work of the Ad Hoc committee, and six other major planning groups had signed on to it. This pleased and



astonished the council, and led to hopes that one more negotiating session might prove decisive. However, when the third meeting broke up without further progress it appeared that Plan SB could not be passed at the final council session before the holidays. After that meeting, Councilman Das Williams will leave to be sworn into his new Assembly seat, and the council will remain split 3 to 3 on whether to approve the Plan. Five affirmative votes are needed to pass the general plan update. Whether the prior desirable compromises will be included in the Plan remains to be seen.

One proposal that came up during the last negotiating session was to remove of all High Density (base zoning 27-45 units per acre) from the city, and make those areas all Medium-High Density (12-25 units per acre). The League, CPA and Allied Neighborhood Association could all support that, but the activists who want to see more building permitted probably will not. The Plan calls for a 50% Overlay for rental or employer-sponsored housing, so that for those categories more units would be allowed. The League has been supportive of allowing even greater density for small units in those two categories, but we have been opposed to allowing more density for market rate units.

voice heard about what you want the League's future to be.

We'll be discussing League policy and positions at the state level.

Using our current positions, which hot issues do we want to focus on for the next two years? League calls these "issues for education and advocacy". For instance, we advocated for redistricting reform (Prop. 11 in 2008), and then against its repeal (Prop. 27) in the November election. Now we are monitoring and participating in its implementation; we've moved from advocacy to community education on this issue.

Is there an issue League should have been able to act on, but can't? If so, should we undertake a new statewide study, or update an old position? What are the issues of special concern to us here on the South Coast? If you want your voice to be heard, then attend the Program Planning meeting. It's the start of the grassroots process, and the place for each of us to make our opinions heard.

As a reminder, we have four discussion units, but some have changed for the coming year.

LETTER FROM LWVUS

I couldn't be prouder of the League this election season. During my [travels to nine states](#) before the elections, I saw firsthand the incredible work done by local Leagues and their volunteers registering tens of thousands of new voters, providing nonpartisan information on the candidates through millions of printed and online voters' guides, and holding hundreds of candidate debates seen and heard by thousands over the course of the campaign.

Our examination of this year's election has brought to light two major players during this election season that demand our immediate attention: [secret money and incivility](#).

When the Supreme Court ruled on the *Citizens United* case earlier this year, huge amounts of secret money were turned loose in American politics. Congress' failure to act and pass the DISCLOSE Act only added to this problem.

As a result, not surprisingly, voters were overwhelmed by millions of dollars in negative ads this year but didn't know who paid for many of them. [Leagues across the country have been calling on their elected officials to support the DISCLOSE Act](#), which would require corporations and unions to disclose the dollars they spend in elections.

With the 2012 presidential election season having already begun on November 3, the League will continue to address the other major issue this election season: incivility. The tone of the 2010 campaign exhibited a disturbingly new low in American politics. Not only was this evident in the expensive advertising, but we also saw it in candidate debates and forums and in the public discourse.

As we have for the past 90 years, the League will continue to help our fellow citizens discuss the issues in a civil and fact-based way, and fight for transparency, accountability, and disclosure in America's elections!

Voters, not money, should be at the center of our democracy.

The Global Democracy program is the League of Women Voters' program for activists and non-governmental organizations worldwide. Working with groups abroad to increase their voice in stressing transparency, accountability, and good governance in their societies, the League assists in expanding community influence in public policy-making processes while helping citizens build leadership skills through interactive, hands-on training and citizen exchange programs. The League partners with groups such as Friendship Force when League members travel to countries around the world to educate themselves, share information with other women and participate in international training programs. LWVUS is registered as a Private Voluntary Organization with USAID and is part of the Registry of Civil Society Organizations with the Organization of American States.

Diefendorf has been a leader in environmental education and has served from 2006 to 2010 as National

Chair of the LWVUS Climate Change Task Force. She is a former 2nd Vice President of LWVUS, and has a remarkable resume that reflects both her professional and volunteer expertise and experience.

She was highly recommended as a speaker by a member of the San Luis Obispo League, which hosted several Ukrainian women for the Global Democracy Program. The Program, which our local League participated in some time ago, brings democratic activists from other countries to be the guests of local Leagues. The San Luis League not only involved all of their members in the hosting but also enjoyed sharing their visitors with county governmental bodies. This is an activity we in Santa Barbara might consider participating in again, as it is not only an educational experience, but also a very enjoyable way of increasing local knowledge of the long reach of the League.

NATIONALLY RECRUITED LOCAL MEMBERSHIP PHASED OUT

Many of our members may be surprised to learn that the League of Women Voters of the US will no longer have or be recruiting individual memberships as of December 31, 2010. The Santa Barbara League will not have your name on its roster if you joined through the National League, unless you choose to renew your membership through our local League.

LWV Santa Barbara invites all of its members to rejoin each September 1st. Membership is \$60 per individual, or \$90 per household, and is subsidized by our League because we send most of this amount as PMP funds (per member payment) to help support the services of the California and national Leagues.

So, if you joined nationally in the last few years and you wish to remain a member of League, **please renew** by sending your membership fee – \$60 single, \$90 household – to Membership, LWV Santa Barbara, 328 E. Carrillo St., Suite A, Santa Barbara, CA 93101.

All LWV members are actually members of all three levels - local, state, and national Leagues. This change in LWVUS policy will eliminate confusion about how to become a member.
