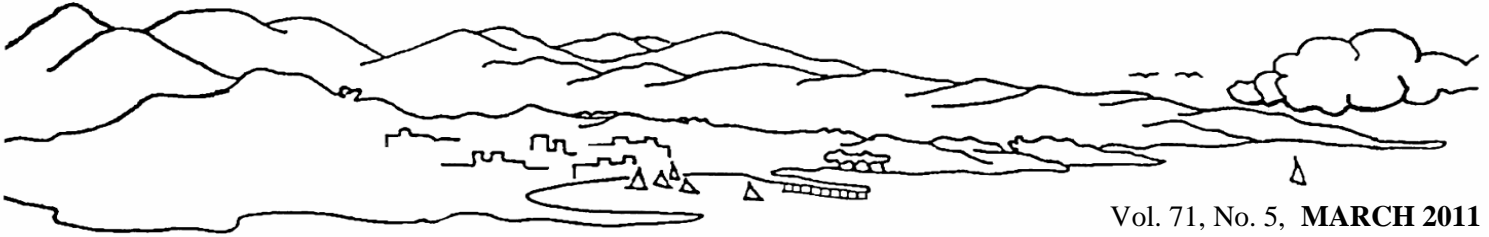

Over the years, we have seen our state government mired in seemingly unfixable challenges. Our legislators balance the budgets, borrowing and leveraging with smoke and mirrors while our local governments--cities, counties, and schools--are suffering, and our business sector is more and more critical of the way we treat businesses here. What is being done to address our state challenges and re-invent state government.

The March Community Forum will focus on California Forward's efforts to work with citizens to help create better government. They believe they can "revive the California Dream and turn our broken government into an efficient, effective body, focused on performance, accountability and transparency." California Forward wants to get everyone involved. Please come and participate in a process that moves us toward solutions and away from blame and pessimism.

As you know, LWVC sponsored the citizens redistricting process for the state, which is working to put legislators in fairer districts, not so attached to one party or the other. There is hope the legislators will be forced to listen and compromise.

We will hear about California Forward and its solutions for our state from **Bruce A. McPherson** who was the CA Secretary of State (2005-07), a State Senator (1996-2004), and a State Assemblyman (1993-96). He was born in Santa Cruz and worked as editor of the Santa Cruz Sentinel, a newspaper owned by his family.

each other. Suddenly, it gave me strength to quickly organize lovely Christmas party to my neighbors."

She went on to say that she no longer works. She gave it up when her husband became seriously ill; he has since died. She has one son doing law for a government agency. One son has lost his business "because of the crisis" and is looking for work. Another son is in Washington and her grandson studies computers in the Technological Institute in Washington. She has not seen the two in Washington for seven years.

Pro-Choice Coalition Update

The 38th anniversary of Roe v. Wade celebration event of the Santa Barbara Pro-Choice Coalition, of which the LWVSB is a member, was a great success. This year, we sponsored two showings of the play, "Jane: Abortion and the Underground," at Center Stage Theater (including a focus group after the Sunday show). The show sold out on Saturday and just 12 tickets went unsold on Sunday. The total of 248 tickets sold represent 2-3 times the typical Roe event attendance. The event reached a diverse audience, with 40% of the attendees UCSB students.

Plans are underway to continue to reach out to UCSB in collaboration with the producer of the play, Carly Thomsen, Ph.D. candidate of the Department of Feminist Studies, UCSB and Planned Parenthood Action Fund Board Member.

Homelessness/Housing Action

With the help of Emily Allen and Connie Hannah (many thanks), the LWVSB presented a statement to City Council on Tuesday, January 25, 2011 in support of the use of Redevelopment Agency affordable housing set-aside funds to acquire the 9-unit building at 2904 State Street. The funding request was granted but then called back for another vote. In the second vote, the City Council approved the use of Redevelopment Agency funding to purchase the building but left open the question of providing supportive services. The Council advised that Willbridge, the non-profit agency that would manage the building, take 90 days to engage with the surrounding community on the scope of supportive services to be provided and report back. Stay tuned for updates.

WRITING ON RICHARD ROTHSTEIN'S REPORT ON REAUTHORIZATION

Renowned education researcher Richard Rothstein gave a talk titled "ESEA Reauthorization: Looking Ahead" at the California School Boards Association annual convention on Dec. 3, 2010. The Elementary and Secondary Education Act (ESEA) is more commonly known to most of us as "No Child Left Behind" (NCLB). Signed into law with high hopes by President George W. Bush with bipartisan support, its reauthorization is complicated by politics and politicians, not to mention principled discussions of educational philosophies and goals.

As an experienced education observer Mr. Rothstein began his talk not about philosophies, but about ...

The politics of it all

The impact of the 2010 election will be felt in ESEA. New Speaker John Boehner was an original supporter of ESEA, while the new chair of the House education committee, Rep. Kline, wants to keep the federal government out of schools. Will Speaker Boehner spend political capital on ESEA reauthorization? This is further complicated by the strange alliances in education. Some Democrats and Republicans are strong supporters of accountability and testing. Others are skeptical of testing and what they see is narrowing of the curriculum. The new Senate ed. chair, Democrat Tom Harkin, strongly supports labor (teachers) and has little interest in testing. But, we may get a coalition for special education funding. However, Republicans are generally opposed to increased spending. If special education gets more funding, what programs would we cut to allow for this?

Special ed. funding has grown by share in education. It's now 23% of all money in education, and the number of children identified is growing (whereas other ed. funding has fallen). **We'd be much better off spending more for high quality early childhood education, says Mr. Rothstein.** (See more below.)

Let's review what NCLB/ESEA does:

[1] Holds schools accountable for basic skills in math and reading, and requires students to pass an annual test on them; [2] Reports scores by subgroups within schools, instead of just by schools (as in the past). Subgroups include Hispanic, African American, Asian, White, low economic status, and special education. [3] Promotes "accountability" by penalizing schools if not all subgroups of students pass the annual tests.

Results of focus on subgroups, testing, and accountability:

1. Narrowing of curriculum, since what's tested (reading and math) is how a school is held accountable. What

isn't tested (subgroups of reading and math, not to mention history, science, art, and music) isn't taught, or at least gets less time.

2. Narrowed focus on individual students that can reach "proficiency" (roughly grade level) with concomitant less attention to students who have already reached proficiency.

"Absurd goal" of 100% proficiency by 2014 and "Closing the Achievement Gap":

This violates everything we know about psychology - to set the same challenging standard for everyone. No educator in his right mind believes we can "close" the Achievement Gap.

Key longitudinal study on language acquisition by babies and toddlers (Hart and Risley):

1. **Children START kindergarten with huge advantages or disadvantages.** Why does Mr. Rothstein believe it's absurd to think we can close the Achievement Gap? Because kindergarteners start school with such a huge differential in normally acquired words. Betty Hart and Todd Risley tape recorded one full hour a month for 2 ½ years in 42 families, categorized as professional, working class, or welfare. By age 3 trends in amount of talk, vocabulary growth, and style of parent/child interaction were well established. Critically, children in professional homes heard 2,000 words per hour in the background, blue collar children heard 1,300 words per hour, and children in welfare homes heard 600 words per hour. Extrapolating this verbal interaction to a year, a child in a professional family would hear 11 million words while a child in a welfare family would hear just 3 million. In fact, by age 3 the *children* from the professional families had a larger spoken vocabulary than the *parents* from the welfare families! These trends continue into elementary school and beyond.

2. **Children START kindergarten with huge differences in their sense of self worth and belief that they can achieve.** Another component of the Hart/Risley study spotlighted the quality of interaction between toddlers and their parents in the 3 groups of homes. 80% of the feedback to children in professional homes was positive. Working class children heard 50% positive comments. And, welfare children heard 80% **negative** comments.

So, what should we be focusing on?

Instead of punishing schools for not getting all students to proficiency, we should:

- Put our attention on high quality parenting and early childhood programs (beginning at or even before birth)
- Help every child get health, dental, and vision care (maybe at school-based health centers) so children can concentrate on their lessons, and
- Help students prepare for careers, not just college.



SUNSHINE WEEK 2011 WEBCAST: THE ROAD FORWARD ON OPEN GOVERNMENT

Why?

The first national "Sunshine Week: Your Right to Know" was launched in March 2005 and will be celebrated in 2011 from March 13-19. Sunshine Week's intent is to raise awareness of the importance of open government to everyone in the community, not just journalists.

Sunshine Week 2011 National Dialogue is brought to you in celebration of Sunshine Week by the American Association of Law Libraries, American Library Association, Association of Research Libraries, Center for American Progress, League of Women Voters, National Freedom of Information Coalition, OMB Watch, OpenThe Government.org, Project On Government Oversight, Sunshine Week, Special Libraries Association, and the Sunlight Foundation.

What?

Two years ago President Obama committed his Administration "to creating an unprecedented level of openness in Government." Toward this end, the Administration has issued policy changes and also has taken steps to make information more available and usable by the public, including setting up Data.gov and requiring agencies to hard-wire openness into the way the government operates. Agencies have taken up the challenge, but more needs to be done.

During this Sunshine Week event, transparency experts from inside and outside government will discuss how these initiatives are being put into practice -- from both a policy and a technical standpoint -- and what more we can and should expect the Administration to do to meet its goal. Panelists will also take questions from the live and viewing audience.

The first panel will cover the policy aspects of the Administration's Open Government Initiative. Invited panelists include David S. Ferriero, Archivist of the United States, Stephen P. Croley, Special Assistant to the President for Justice and Regulatory Policy, White House Domestic

Policy Council, and Gary Bass, Executive Director, OMB Watch.

During the second panel, our panelists will discuss the effect technology has on the way people get and use information, how the government is trying to fill that need, and the strengths and limitations of the Administration's approach. Invited panelists include Todd Park, Chief Technology Officer U.S. Department of Health and Human Services; Jennifer LaFleur, Director of Computer-Assisted Reporting at ProPublica (CONFIRMED); Tom Lee, Director of Sunlight Labs at the Sunlight Foundation (CONFIRMED); and Sheila Krumholz, Executive Director of the Center for Responsive Politics (CONFIRMED).

Opportunities will be available for audience questions from all participants.

When and Where?

The event will be held on Friday, March 18, 2011 9:00-10:30am (PST) at the Center for American Progress (1333 H Street, NW), and webcast to sites around the country.

How?

To view the webcast live on your personal computer, no pre-registration is required. Simply visit the Center for American Progress' events page at <http://www.americanprogress.org/events> the day of the event. You can watch the webcast on your own, or with a group. About 24 hours before the event, you will have the opportunity to test the webcast, and call someone to help with any technical difficulties.

The panel discussion will be shown at locally hosted discussions in communities across the country. At this writing, we do not know of any group viewings in our area. Call our office at 965-2422 if you'd like an update on this, or would like to host a group viewing.
